**BY PARTICIPATING IN THE 2022 BOURBON MIXER PAPPY VAN WINKLE & W.L. WELLER RAFFLES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT.**

- 1. Sponsor.** The Coalition for the Homeless (“The Coalition”) is the sponsor of the 2022 Bourbon Mixer Pappy Van Winkle & W.L. Weller Raffles (the “Raffles”). The Coalition is a 501(c)(3) non-profit organization. The purpose of the Raffles is to raise funds for the operation of the Coalition for the Homeless in Louisville, KY and for the related activities of The Coalition.
- 2. Raffle Overview.** The Raffles begin on July 1, 2022 and end on August 20, 2022, or when tickets are sold out, whichever occurs first.
- 3. Eligibility.** Any person 21 years of age or older, residing in the United States where the Raffles are not prohibited, may purchase one or more tickets (“Ticket”) to be entered in the Raffles (such person shall be herein known as the “Ticket Holder”). An affidavit of eligibility may be required from Ticket Holders who win a prize. Staff members of the Coalition and their immediate family members (in this instance known as spouses and children), are prohibited from purchasing Tickets.
- 4. Rules.** By purchasing a Ticket, each Ticket Holder accepts and agrees to be bound by all the rules, limitations, conditions, and restrictions set forth herein (the “Rules”), as well as all applicable local, state, and federal laws and regulations. The Coalition’s decisions in all matters concerning the Raffles and its interpretation and application of the Rules shall be final. Please contact the Coalition if you have questions regarding the Rules or the Raffles. The Raffles are void where prohibited by law.
- 5. Releases.** By purchasing a Ticket, each Ticket Holder releases the Coalition, its directors, officers, employees, and agents, from any and all liability with respect to the Raffles, including, but not limited to, the selection process and the interpretation and application of the Rules, and from any and all liability for injuries, losses, or damages of any kind caused by any prize or resulting from acceptance, possession, use, or misuse of any prize, and each Ticket Holder agrees to indemnify and hold the Coalition harmless from any and all losses, damages, rights, claims, and actions of any kind arising in connection with or as

a result of the winner's acceptance or use of any prize. Each Ticket Holder agrees that their name, likeness, and any statements made by them regarding the prize may be disclosed to, and used by, the news media and may otherwise be used by the Coalition for advertising or publicity purposes without compensation, and in any lists of prize winners to be published.

**6. Tickets.** The cost to purchase a Ticket for the Pappy Van Winkle Flight Raffle is \$100.00 (U.S. Funds only). A maximum of 2,000 Pappy Van Winkle Flight Raffle Tickets will be sold. The cost to purchase a Ticket for the W.L. Weller Flight Raffle is \$25.00 (U.S. Funds only). A maximum of 2,000 W.L. Weller Flight Raffle Tickets will be sold. Each Ticket has one number. Each ticket qualifies as a raffle entry for one prize only. To be eligible to win both prizes, an entrant must purchase two separate tickets, one for each Raffle. Any eligible person may purchase more than one Ticket. Odds of winning depend on the number of valid Tickets sold. Tickets will not be sold after 8:30pm EDT, Saturday August 20, 2022. Any unsold tickets become the property of the Coalition and will not be included in the drawings. Ticket Holders will receive an email confirmation of their payment that includes a payment confirmation ID. The payment confirmation ID should not be confused with Raffle Ticket numbers. Raffle Ticket numbers will be assigned to each Ticket Holder and posted online at [www.bourbonmixer.com/raffle](http://www.bourbonmixer.com/raffle). The IRS has taken the position that amounts paid for chances in raffles, lotteries, or similar drawings for valuable prizes are not gifts, and consequently do not qualify as deductible charitable contributions. A Ticket is not valid and shall not be entered in the Raffles until full and satisfactory payment for such Ticket is received by the Coalition. Tickets are not transferable once purchased.

**7. Failure of Payment.** If a Ticket Holder's payment by credit card is declined or check is dishonored by the bank for any reason, such Ticket Holder's Ticket shall be invalid and will not be entered in the drawing, unless full and satisfactory payment is made by 8:30pm EDT, Saturday August 20, 2022. The Coalition will endeavor to notify the invalidated Ticket Holder by phone at the number provided on the ticket purchasing website; however, any failure to do so shall not cause the Ticket to become valid, cause the Ticket to be entered in the Raffles, or give rise to any claim or cause of action on behalf of the invalidated Ticket Holder.

**8. Multiple-Party Tickets.** In the event that more than one name is listed on a Ticket, the first name listed shall be deemed to be the Ticket Holder. Delivery or payment of the prize shall be made to the Ticket Holder. It is the responsibility of the Ticket Holder to allocate any such prize among the participants in a multiple-party Ticket and the Coalition, its directors, officers, employees, and agents, shall have no liability for any failure to do so.

**9. Raffle Drawings.** The Raffle Drawings shall take place on Saturday August 20, 2022 at 9:00 pm EDT at the Bourbon Mixer event at The Henry Clay, 604 S Third Street, Louisville, KY 40202. Attendees of the Bourbon Mixer event must purchase an event ticket (limited in number) to view the raffle drawings. Anyone can view the raffle drawings live online at [www.facebook.com/BourbonMixer](http://www.facebook.com/BourbonMixer). In order to be eligible for the Raffle Drawings, a Ticket Holder must have purchased their Ticket online before 8:30pm EDT, Saturday August 20, 2022. The winning Ticket for each Raffle will be randomly chosen, and the winners of the prizes will be the Ticket Holders who have purchased a valid Ticket whose Ticket number matches the number chosen. If the Raffles are held, all prizes will be given away. If the Raffles are not held, all money will be returned to the Ticket Holders. There is no substitution of prizes. **TICKET HOLDERS NEED NOT BE PRESENT TO WIN.**

**10. Claiming a Prize.** Winning Ticket Holders will be notified by phone and/or email at the number or email address provided via website when purchasing the Ticket. The Coalition shall notify the winners within three days of the drawing. The winners shall claim the prizes within thirty days of the drawing or will forfeit all rights to claim the prizes. The names of the winners will be available online at [www.bourbonmixer.com/raffle](http://www.bourbonmixer.com/raffle).

**11. Obligations of Winning Ticket Holders.** Except as otherwise provided herein, the Ticket Holders who win the prizes are responsible for all costs associated with that prize, including, but not limited to, any local, state, and federal taxes that may be applicable. Ticket Holders are advised to consult with a tax advisor to determine any tax liabilities. The prize will be delivered to a winner within 300 miles of Louisville, Kentucky or will be made available for in-person pick-up in Louisville, KY upon request. Signature will be required upon delivery. In certain cases, the items may be delivered in person by staff, board members, or volunteers. Winners residing farther than 300 miles from Louisville will be given a \$300 cash gift card to offset the cost of travel.

**12. Raffle Prizes.** There is one winner and one prize for the Pappy Van Winkle Flight Raffle. The prize is six bottles of Old Rip Van Winkle whiskey: Old Rip Van Winkle 10-Year Bourbon, Van Winkle Special Reserve 12 Year Lot B Bourbon, Van Winkle Family Reserve Rye Whiskey - 13 Years Old, Pappy Van Winkle Family Reserve - 15 Years Old, Pappy Van Winkle Family Reserve - 20 Years Old with bag and tag, and Pappy Van Winkle Family Reserve - 23 Years Old with bag and tag. There is one winner and one prize for the W.L. Weller Flight Raffle. The prize is six bottles of W.L. Weller Whiskey: W.L. Weller 12 Year Old Kentucky Straight Bourbon Whiskey, W.L. Weller "Craft Your Perfect Bourbon" Bourbon Whiskey, W.L. Weller Full Proof Kentucky Straight Bourbon Whiskey, W.L. Weller Single Barrel Kentucky Straight Bourbon Whiskey, W.L. Weller Special Reserve Kentucky Straight Bourbon Whiskey, and W.L. Weller Antique 107 Proof Kentucky Straight Bourbon Whiskey.


